IFC and Partners: New Roadmap from Outlines Net-Zero Pathways for Mining Green Tech Metals

The International Finance Corporation (IFC) launched the Net-Zero Roadmap for Copper and Nickel Mining Value Chains, a new solutions guide aimed at decarbonizing the mining of critical minerals. The Net-Zero Roadmap for Copper and Nickel Mining was prepared by IFC as part of the World Bank Group's Climate Smart Mining Initiative, and delivered by the Carbon Trust, RMI, The Payne Institute for Public Policy at the Colorado School of Mines, and Columbia Center on Sustainable Investment.

Copper and nickel are key components of green energy technologies needed to combat climate change, including solar panels, batteries, and wind turbines. According to the roadmap, the world will need to increase copper and nickel production by 200–300 percent to reach global climate targets by 2050. But emissions from copper and mineral production processes are expected to double by 2050 unless a decarbonization transformation takes place. Decarbonization of the mineral sector will be important to ensure that end-users and consumers are able to meet their own Scope 3 net-zero targets.

An international team of researchers has published a study in the journal *Ecology and Evolution* showing that the destruction of key hydrothermal vents by deep-sea mining could have knock-on impacts on vent fields hundreds of kilometres away.

Driving Force: Report on Automotive Supply Chains and Forced Labour in the Uyghur Region

If you have bought a car in the last five years, some of its parts were likely made by Uyghurs and others forced to work in China. The Chinese government has deliberately shifted raw materials mining and processing and auto parts manufacturing into the Xinjiang Uyghur Autonomous Region, essentially making international supply chains captive to repressive programs and systematic forced labour.

In a six-month investigation undertaken by Laura T. Murphy, Kendyl Salcito, Yalkun Uluyol, Mia Rabkin, and a team of anonymous researchers, analysis of publicly available documents revealed massive and expanding links between western car brands and Uyghur abuses, in everything from the hood decals and car frames to engine casings, interiors and electronics.

Study on responsible procurement in the IT industry

In the study "Raw materials in the focus of IT procurement", WEED (World Economy, Ecology & Development) examines the extent to which actors from the electronics sector are procuring raw materials responsibly. From its findings WEED made suggestions for further public procurement. The study is aimed at procurement managers and is intended to create incentives to integrate social and ecological criteria more strongly in the procurement of IT products.

BMZ launches Feminist Development Policy

Development Minister Svenja Schulze has presented her strategy for a feminist development policy. The aim is to guarantee women the same rights and access to resources as men, and to work towards ensuring that women are equally represented and involved in political and economic decision-making processes.

By 2025, more than 90 percent of the newly committed project funds of the Federal Ministry of Economic Cooperation and Development (BMZ) are to flow into projects that advance gender equality. Minister Schulze briefed the Federal Cabinet on the strategy today - together with Foreign Minister Annalena Baerbock, who provided information on her guidelines for a feminist foreign policy. Feminist foreign policy and development policy complement each other in their goal of equal participation of all people.

Gender assessment of employment and skills in the large-scale mining sector of Argentina

This study establishes a baseline profile of women employed in the mining industry and its supply chain. It analyses the gaps, progress and challenges of female participation in the large-scale mining labour market in Argentina, which is a key country in lithium production and with significant reserves. The document also includes recommendations for both public and private actors, to advance towards equal opportunities in the mining sector.

The publication is part of the global project "Women and the Mine of the Future", launched by the Intergovernmental Forum on Mining, Minerals, Metals and Sustainable Development, in collaboration with the International Labor Organization, the United Nations Development Program and International Women In Mining.

Changing the narrative around women in mining


Women make up just 12 % of the South African mining industry, which puts the industry behind others in the country. The participation of women in business is empirically shown as positively influencing a company's bottom line and contributing to enhanced sustainability. Critical for mining companies, gender-inclusive workplaces are also shown to be safer. Why then do South African mining companies still struggle to change their gender profile?

S&P Global Research: Lithium supply race – delayed hope in 2024

China's battery-grade lithium carbonate ex-works price remained strong in 2022 after more than quadrupling in 2021 and rising more than 1,200% from its lowest level in July 2020. Strong demand from the electric vehicle market and slower-than-expected project commissioning have pushed lithium prices to record highs. S&P Global Commodity Insights expects a 2026 lithium carbonate CIF Asia price of \$42,093 per tonne, which will incentivize lithium miners to move forward with new projects to meet the demand forecast to grow at a 22.4% compound annual growth rate over 2022-26. We have identified 16 projects that have set first shipment targets in 2023-24, comprising 10 hard rock and six brine, making up nine concentrate and seven chemical operations. These 16 assets will bring 567,941 tonnes of lithium carbonate equivalent, or LCE, capacity online by the end of 2024.

Annual clean energy investment reached \$1.1 trillion

Last year was a double milestone for decarbonizing the world's energy system. It was the first year when investment in the energy transition equaled global investment in fossil fuels, according to the latest data release from clean energy research group BloombergNEF.

The money flowing into the upstream, midstream and downstream segments of oil and gas, and into fossil fuel-fired power generation without emissions reduction technology, was \$1.1 trillion last year. Likewise, annual investment in renewable energy, electrified transport and heat, energy storage and other technologies reached \$1.1 trillion.

Mining Indaba brought together investors, mining companies, governments as well as other important actors of the sector. A side event day organised by the Sector Programme "Extractives and Development" will review the issue on a working level with several partner organisations on May 31.

Did you know...?

... that Cobalt used to be a beer additive? In the quest for a perfect beer head, breweries in the mid-20th century began adding cobalt sulfate to beer to stabilise the foam. This practice conveniently mitigated the impacts of a poorly rinsed glass (the leftover detergent caused foam dissipation). However, a study conducted in 1965 in Nebraska and Quebec detected unusually high levels of cardiomyopathy in beer drinkers. Further research confirmed that heavy beer drinkers at breweries using this practice were in fact overdosing on cobalt, and at risk of heart failure. The use of cobalt in beer was thankfully discontinued after this discovery – and one can only assume that beer glasses are rinsed properly these days!
