Launch of OECD Handbook on Environmental Due Diligence in Mineral Supply Chains

The OECD Centre for Responsible Business Conduct with the support of the German Federal Ministry for Environment, Nature Conservation, Nuclear Safety and Consumer Protection (BMUV), the Federal Institute for Geosciences and Natural Resources (BGR) and the German Environment Agency (UBA) has developed a Handbook on Environmental Due Diligence in Mineral Supply Chains to support implementing due diligence recommendations to address adverse environmental impacts in the mining sector. The final Handbook will be presented and discussed at the closing conference of the Re-Sourcing project on September 21 and 22 at the Vienna University of Economics and Business.

Over 50 African countries agree to work on minimising impacts of mineral mining

At the nineteenth ordinary session of the African Ministerial Conference on the Environment (ACMEN), which was held from 14 to 18 August 2023 in Addis Ababa, Ethiopia, under the theme "Seizing opportunities and enhancing collaboration to address environmental challenges in Africa",

the Environment Ministers of over 50 African countries agreed on addressing and minimising adverse environmental impacts of mineral mining. In the draft declaration 54 African Ministers for the Environment declare their resolve to institute national and regional strategies to minimise environmental impacts in the extraction and processing of mineral resources. Furthermore, they agreed to call upon ACMEN Member States to consider prioritising

environmental policies to assess the environmental impacts and trade-offs in the extraction, processing and refinement of critical minerals needed for the global transition to clean energy.

EPRM will launch its next Call for Proposals from 1 September 2023

The European Partnership for Responsible Minerals (EPRM) will launch its next Call for Proposals (CfP) from 1 September 2023. EPRM seeks to improve the social, environmental and economic conditions for mine workers and local mining communities especially in artisanal and small scale mining (ASM). The budget for this CfP is EUR 2 million with its mineral scope including tin, tantalum, tungsten, lithium, natural graphite, cobalt, copper and nickel. Gold has been excluded from this call. EPRM broadened the minerals scope for this CfP to emphasise that ASM must become a part of the energy transition to achieve the ultimate goal of a just energy transition.

The deadline to submit a quick scan (compulsory) will be from 1 September 2023 to 16 November 2023 (before 14.00 hrs CET) and to submit a full project proposal from 1 October 2023 to 30 November 2023 (before 14.00 hrs CET).

EPRM will hold online information sessions in English (11.00-12.00 hrs CET), French (14.00-15.00 hrs CET) and Spanish (16.00-17.00 hrs CET) on 7 September 2023 to provide relevant background information on the process of submitting.

EU Council adopts new regulation on batteries and waste batteries

The Council of the European Union (EU) has adopted a new regulation that strengthens sustainability rules for batteries and waste batteries. The regulation aims to create a circular economy for the batteries sector by targeting all stages of the life cycle of batteries and to reduce social and environmental impacts throughout the life cycle of batteries. It also sets tight due diligence rules for the sources of raw

materials used for batteries placed on the European market and introduces labelling and information requirements on the battery's components and recycled contents such as an electronic "battery passport". After signature by the European Council and the European Parliament, the regulation will be published in the EU's Official Journal and enter into force 20 days after.

Levin Sources article: LGBTQIA+ rights are human rights: Paving the way for inclusion in responsible mineral sourcing discourse

Lesbian, Gay, Bisexual, Trans, Queer, Intersex, Asexual and other (LGBTQIA+) rights are rarely

integrated into the discourse of responsible mineral supply chains. The article by Levin Sources sheds light on this important topic by speaking with two entrepreneurs and activists in the upstream and downstream minerals sector. Elaborating those experiences, the article demonstrates how queer individuals face significant barriers preventing them from fully enjoying their human rights. This illustrates the need to integrate LGBTQIA+ rights into the responsible sourcing discourse, creating an environment that embraces inclusivity and safeguards the well-being of people irrespective of their sexual orientation or gender identity. In addition to the article, an interview with Jérémie Safari, Executive Director of Rainbow Sunrise Mapambazuko, was published.

Article by S&P Global: African mining companies outpace global peers on women in leadership

More women sit at the top of Africa-based metals and mining companies than the global average, an analysis of S&P Global Market Intelligence data shows. The dataset for publicly traded miners in Africa is relatively small, comprising just 16 publicly traded companies headquartered in Mauritius, Morocco, South Africa, Tanzania and Zambia. The larger global dataset comprises more than 2,000 global metals and mining companies. However, among those companies in Africa, women hold 32.0% of the executive roles, 23.9% of the C-suite roles and 26.5% of the board roles.

Women make up a relatively small portion of the global mining industry's leadership positions, filling 14.0% of executive roles, 12.3% of board roles and 12.1% of C-suite roles, according to a Market Intelligence data analysis released in May. South Africa and Zambia, two stand-out countries regarding women in leadership roles in the publicly-traded mining sector, have long histories of racial tension, and the efforts made to address that inequity have also boosted the numbers of women in top positions.

UNCTAD: Economic Development in Africa Report 2023

The United Nations Conference on Trade and Development (UNCTAD) recently launched its "Economic Development in Africa Report 2023". The focus of the report is an examination of Africa's potential to capture technologyintensive global supply chains. This includes hightechnology sectors like automobiles, mobile telephones, renewable energy and health care. As raw materials are needed for all these sectors, mining plays a pivotal role in the report.

African economies can become major participants in global supply chains by harnessing their vast resources of materials needed by high-technology sectors and their own <section-header>

growing consumer markets. To help them capitalize on their comparative advantages, the report recommends policy actions to ensure an attractive business and investment environment and new market opportunities.
